The construction sector is a key sector of German economy. With an **investment volume over 320 billion Euros**, the construction sector provides more than **830,000 jobs** and training positions. In all **3,3 million jobs depend on the construction sector**.

In German and European standardisation bodies, we represent the interests of our members. We advise our members and offer new business models in changing economic conditions.



Types of Procedures 程序类型

Open Procedure 公开程序

In this procedure all interested contractors may participate and submit a tender.

在此程序中, 所有感兴趣的承包商均可参与并提交投标书。



Restricted Procedure 限制程序

The Restricted Procedure is a 2-step-procedure. 限制程序共有两个步骤。

As a first step the contracting authority publishes an invitation to participate. 第一步,订约当局发出投标邀请书。

Then a limited number of interested contractors are selected by the authority to submit a tender.

然后, 当局限额选取感兴趣的承包商提交投标书。



Negotiated Procedure 协商程序

In this procedure, the authority consults the contractors of its choice either with or without a contract notice.

在此程序中,无论是否有合同通知,当局都将与其选择的承包商进行协商。

The contracting authority negotiates the terms of the contract with one or more of the chosen operators.
